Lawn Watering Between 12am-5am



Are you watering between the hours of 12 am and 5 am? If you are, then you are abiding by the city ordinance approved in 2008. If not, now is the time to program your automatic sprinklers for summer.

The watering ordinance applies to all customers of the Citys water supply system. Outdoor watering by means of an automatic or programmable landscape irrigation system may be done only between the hours of midnight and 5 am Michigan time. Water may be used at any time to manually irrigate landscaping. An automatic or programmable landscape irrigation system may occasionally be used in unprogrammed manual mode for brief periods and as necessary for testing, repair and winterizing purposes.

Friendly Reminder: EPOA RESTRICTIONS

This list is not all-inclusive:

- Sheds of any design whatsoever are expressly prohibited.
- All waste shall be kept in a sanitary container, properly concealed from public view. (This includes trash cans)
- No free-standing, above ground-level swimming pools are permitted under any circumstances. In ground swimming pools may be installed, when approved in writing, by the Board of Directors.
- No trailers, boats, boat trailers, campers, junk cars, motorcycles, motor homes or commercial vehicles, other than those present on business and during business hours, may be parked in the subdivision, unless they are parked inside your attached garage.
- No clothes lines or outside drying of laundry is permitted.
- No lot perimeter fencing is allowed.
- No alteration or addition to an existing home may be constructed until plans and specifications have been submitted to and approved in writing by the Board of Directors.

C: Comment from resident R: Response from Association

C: Love the neighborhood. Would like to see sidewalks on Bembridge

R: Unfortunately when the subdivision was planned it was planned with no sidewalks. Sidewalks cannot be added due to utilities running underground in the area on where a sidewalk would be located.

C: Request for a bike rack at Windrift MS/HS school bus stop

R: We could not add a bike rack at the corner of Windrift as this is private property. EPOA can investigate a possible bike rack in the commons area on Eddington.

C: Good job with holiday lighting!

R: Thank you so much. The holiday lights were contracted to Christmas Express. We have signed a 3 year contract with them.

C: Road in front of 372 Essex has many cracks. Please consider this, it makes lots of noise.

R: The roads are maintained by the City of Rochester Hills. If you have any issues, please contact the City of Rochester Hills Road Division at 248 656 4685.

C: Speed Bumps are needed on Bembridge.

C: Spend some money on Bembridge entrance.

R: Regarding spending money on the Bembridge entrance, we have investigated added sprinklers and lighting to the entrance but it would be very expensive to complete this task. We put a new sign in 4 years ago along with solar LED lighting. We plan on evaluating the lighting this year and updating the solar lights if needed. We do plant flowers and decorate for the holiday every year.
